- Session analytics

We use third-party tools for analytics and performance tracking including:

- Google Analytics 4
  - Google Tag Manager
  - Amplitude
  - Microsoft Clarity

We use the collected data to:

- Register and identify users
  - Send job alerts via Telegram
  - Improve user experience and analyze platform performance
  - Ensure security and prevent abuse
  - Communicate with you about updates and services

We process your information based on:
